#### **FORMATS**

PAIRS – ONE LEAGUE OF FOUR OR FIVE TEAMS. ALL GAMES TO BE PLAYED NOT LATER THAN SATURDAY 29<sup>th</sup> MARCH. THERE WILL BE NO EXTENSION FOR ANY REASON.

**SINGLES** – TWO GROUPS OF FOUR, WINNERS AND RUNNERS-UP TO SEMI FINALS, THEN TWO SEMI FINAL WINNERS TO FINAL. GROUPS AND RINKS TO BE DRAWN ON THE DAY. MATCHES OF 6 ENDS IN GROUP STAGE, TWO POINTS FOR A WIN, ONE FOR A TIE. 8 ENDS IN KNOCKOUT MATCHES WITH SUPER END IF REQUIRED IF SCORES ARE LEVEL.

## **RULES - THERE HAS TO BE SOME RULES!**

In general we follow the rules of Bowls Algarve, which we are accustomed to in the Leagues.

The important ones in brief :-

**Singles matches** – short format tournament as above. **NO TRIAL ENDS** but you may practice on adjacent rinks not being used for the competition.

Pairs matches will be 18 ends. Two points for a win, one point for a tie.

Any pairs match that has to be suspended before completion of the 15<sup>th</sup> end and cannot resume within 30 minutes will be replayed. A match that is suspended after the completion of the 15<sup>th</sup> end may either be replayed in its entirety, resumed on a different date for the remaining ends to be played or recorded as completed, according to the circumstances. The Bowling Committee will discuss with the players concerned before issuing a decision.

**Rink settings** will be according to the setup as available on the day. If teams cannot agree which rink is to be used, lots to be drawn. Likewise if more than one match is scheduled at the same time, including those in another competitions.

#### Toss for first mat.

**Substitutes** WILL NOT BE ALLOWED except as a permanent replacement and with the approval of the Bowling Committee. Should a pairs team withdraw completely, the Bowling Committee will rule on whether their games should be deleted from the overall record or some other action taken.

End of competition tie breaks:

If teams or players finish with an equal number of points the tie break process will be as follows:

- 1. Best overall shot difference
- 2. Most shots scored
- 3. Most matches won
